Conclusion of an agreement on labour management

The agreement can be concluded from 32 weeks of pregnancy. You need to make a mandatory consultation before concluding an agreement on labour management, which includes consultation with an obstetrician-gynecologist, drawing up an individual labour management plan and additional medical examinations, when indicated*.

If you have a concluded insurance policy "Protected Pregnancy" for the I or II trimester, it is possible to conclude an agreement on labour management from 22 weeks of pregnancy. In order to do that, it is necessary to undergo a mandatory consultation with an obstetrician-gynecologist.

Price of packages on labour management

The maternity hospital "Leleka" provides packages on labour management such as «Ordinary childbirth»², "Standard", "Comfort", "Lux" and VIP, which differ in additional services, the number of rooms in the general room and design.

Services provided by the selected package on labour management

Delivery and health assessment of a newborn

- 1. Delivery in an individual delivery room with a medical team: midwife, obstetrician-gynecologist, anesthesiologist, neonatologist, nurse, nursing staff. All delivery rooms in the maternity hospital "Leleka" have shower rooms with a toilet and a washbasin.
- 2. The maternity hospital "Leleka" supports delivery with the partner. A maximum of one close person can be present in the delivery room with the expectant mother. It is necessary to have a fluorography examination (X-Ray) result showing the absence of pathological changes of lungs.
- 3. Health assessment of a newborn, if necessary stay in the intensive care unit with round-the-clock health monitoring by medical staff. Round-the-clock cerebral function monitoring is indicated to preterm infants.

² Additional medical examinations, if indicated, are not included in the price of the «Ordinary childbirth» package

³ There is no possibility of concluding a contract for multiple pregnancy with packages: "Ordinary childbirth", "Standard", "Comfort". For high-risk pregnancies, it is not possible to enter into an agreement with the package "Ordinary childbirth".

⁴ Stay and treatment of the newborn in the intensive care unit is included in the cost of the package "Ordinary childbirth". All additional days of stay (regardless of the number of days) in BITN, the patient pays separately: 25 000 UAH or 50 000 UAH, depending on the degree of complexity.

- 4. After physiologic delivery, a recently delivered woman stays in the delivery room under the supervision of a midwife and neonatologist for 2 hours, and undergoes the process of contamination. The first breastfeeding is performed.
- 5. After a caesarean section, a recently delivered woman and a newborn are transferred to the intensive care unit (immediately after the end of the surgery). In case of delivery with the partner, a close person may be present in the intensive care unit. In this case, the process of contamination of a newborn happens on the partner's chest.
- 6. Adequate neonatal care is provided to a baby (babies) with gestational age from 22 to 34 weeks or more who need intensive care. It provides for 28-day stay of a baby in the intensive care unit provided that the patient has a valid health insurance policy "Protected Pregnancy" (except for the package "Ordinary childbirth " *).

Postpartum period

- 1. The mother of a newborn in the intensive care unit is provided with a stay in the hospital according to the selected package.
- 2. Adequate four-meal healthy diet from the own restaurant "Leleka", taking into account the recommendations of the nutrition nurse and the wishes of patients (vegetarianism, allergies, religious beliefs).
- 3. Round-the-clock monitoring and health care services delivery to a mother with a newborn, assistance in caring for a baby.
- 4. Assisting in the establishment of breastfeeding, if necessary consultation with a psychologist and specialist physicians (in the package «Ordinary childbirth» assistance is provided subject to payment for an additional stay).
- 5. Providing a mother and a baby with everything necessary for a comfortable hospital stay (medicines, personal hygiene products, disposable clothing sets).
- 6. Additional services.¹

The period after discharge from the maternity hospital

If the state of a recently delivered woman worsens within 42 days after delivery, a consultation with the obstetriciangynecologist of the maternity hospital is provided.

For patients who underwent management of pregnancy in the maternity hospital "Leleka", the maternity welfare center "Leleka" in Pechersk provides after delivery a consultation with a obstetrician-gynecologist who monitored your pregnancy (within 60 days).
